### **Okete Estuary Restoration:**

This morning Murray Grant, Jo & Shaun Wallis and Callum Bourke (Waikato Regional Council) met to review and plan for the future of this project. Both the owner and the Waikato Regional Council were pleased with the weeding and planting this year. The Trust received over \$5,000.00 for this work. This will be used as part of the Pureora predator control funding and to get L.Gardener training and his full driver's licence. It will also help pay some processing fees for the wild venison and pork contributed by the Oliver Family. This meat is really appreciated by our volunteers and clients when we have no funding to pay for our environmental work.

Callum Bourke is happy to work towards another 2,000 natives being supplied for this project at \$5/plant inclusive of planting and releasing obligations from us.

Mr and Mrs Wallis are to fence off identified areas so the planting is safe from stock ingress.

## **Pureora Predator Control:**

We have been successful with funding applications totalling approximately \$10,000.00 for this project. We plan to utilise some of the \$5,000 above as well. We have made recent funding applications with Lion Foundation and WWF for the balance.

Gerry Kessels, ecologist and commissioner, is assisting with the trap placement plan and other issues.

Wallace Narbi has been undertaking trapping with an Auckland tramping club for many years on land near Rangitoto Lands. We are to meet with him there to discuss the most efficient way for both groups to work co-operatively in the area.

## Ngati Haua (Waharoa):

Pari Kaukau has joined us at Tauwhare and Okete on two separate occasions. He has brought up to 5 youth each time and helped with releasing and planting. Some wild pork was gratefully received.

Pari is working with the Mayor, Ash Tanner of Matamata Piako District Council, to try and secure a place for the container to be placed. It seems logical for their local youth to learn how to make the traps as some of them are about to become employed as trappers.
